Definitions:

Standing Committee:

Shall be defined as a committee outlined in section 1 of this Bylaw.

Ad-Hoc Committee:

Shall be defined as a committee formed in order to complete a specific task or objective, and is dissolved after the completion of said specific task or objective.

2. Governance

- I. The President shall be an ex-officio member of all Standing and Ad-Hoc Committees.
- II. Each Standing Committee shall meet no less than three out of the four months in a semester during the academic year.

term, to be submitted to the Vice President of Operations in time for the relevant Honorarium Meeting.

- IV. The Council shall not consider the honorarium of committee members if there is no term report provided by the committee.

3. Membership

- I. Each Standing Committee shall comprise the Chair and Associated Director. In the event that Associated Directors do not have a Vice President, the President in conjunction with the Vice President of Operation will assign necessary work.
- II. It will be left to the discretion of the Chair of each Standing Committee to determine the number of GCSU members that can be appointed to each committee.
- III. In order to have voting rights on a Standing Committee, members of the committee must be members of the GCSU as defined by Part 4 of the Constitution and Bylaw 3: Membership.
- IV. A list of active members must be submitted to the Vice President of Operations, along with the committee term reports.
- V. Committee members may be removed from a Standing Committee if they are absent for more than two Committee meetings consecutively, at the discretion of the Chair of the Committee in consultation with the Vice President of Operations.

- VI. Any member of the GCSU is permitted to attend the meetings of any standing committee.
- VII. The Academic Affairs Committee shall comprise the Senators in their equivalent capacity as Vice Presidents of Academics Affairs.
- VIII. The Bilingual Affairs Committee shall comprise the Vice President of Bilingual Affairs, the Bilingual Affairs Director, the French Translator and the Spanish Translator.
- IX. The Campaigns and Advocacy Committee shall comprise the Vice President of Campaigns and Advocacy, and Campaigns and Advocacy Director.
- X. The Communications Committee shall comprise the Vice President of Communications and the Officers of Promotions.
- XI. The Directors Committee shall comprise all Directors and the President.
- XII. The Executive Committee shall comprise all Executive members of the Council, as defined by Section 2, Part 7.3 of the Constitution.
- XIII. The Finance Committee shall comprise the Chief Financial Officer and the President.
- XIV. The First-Year Experience Committee shall comprise the Orientation Chairpersons and the First Year Representatives.
- XV. The Officer of the Union Committee shall comprise all of the Officers of the Union and the President.
- XVI. The Operations Committee shall comprise the Vice President of Operations, Council Director, and the Services Director.

- XVII. The Social Affairs Committee shall comprise the Vice President of Social Affairs and Social Affairs Director.
- XVIII. The Student Organizations Committee shall comprise the Vice President of Student Organizations, the President, the Student Organizations Director, the Chief Financial Officer, the Chief Equity Officer, and the Vice President of Bilingual Affairs.
- XIX. The Student Wellness and Athletics Committee shall comprise the Vice President of Student Wellness and Athletics.

4. Committee Chairs

- I. The Academic Affairs Committee shall be co-chaired by the Vice Presidents of Academics Affairs.
- II. The Bilingual Affairs Committee shall be chaired by the Vice President of Bilingual Affairs.
- III. The Communications Committee shall be chaired by the Vice President of Communications.
- IV. The Campaigns and Advocacy Committee shall be chaired by the Vice President of Campaigns and Advocacy.
- V. The Directors Committee shall be chaired by the President.
- VI. The Executive Committee shall be chaired by the President.
- VII. The Finance Committee shall be chaired by the Chief Finance Officer.
